Introduction

We, the J.K. Group of Companies, have its origin in the city of Faisalabad, home of textiles in Pakistan. It has an enviable business history of over six decades from the modest start in 1958 with the formation of J.K. Group, culminating into a leading manufacturer / exporters of textile products.

Current Setup

Group owns a big setup of Textile Spinning / Weaving / Processing / Stitching under the umbrella of J.K. Spinning Mills Limited, a public limited company listed on Pakistan Stock

Exchange. It comprises of 204,334 spindles having capacity to produce around 35000 ton cotton / polyester yarn per annum, in addition to spinning operations, the Group also has its own in-house weaving, processing and stitching facilities, producing and exporting range of products including Fabric Sheeting, Percale, Drill, Twill, Stripe Satin, Hospitality Textile, Hospitality Garments, Home Textile, Terry Towels, etc. in global markets.

Company has installed its own gas-based power generation having capacity to produce 23 MW, parallel to national grid supply.

Further, a solar power plant, having capacity to produce 4.0 MW has also been installed to promote green energy.

Future Plans

Another state-of-the-art unit of 6,600 Rotors of open-end machines will be added.

Company is also expanding its processing unit capacity from 5.0 million meters to 6.5 million meters per month which is currently underway.

Company has also planned to setup a weaving unit in near future, comprising of 144 air-jet looms. It will be a state-of-the-art project, will be producing 18 million meters of fabric per annum, targeting the customers in global markets.

Capacity of solar power will be increased from 4.0 MW to 13.0 MW in near future, for that the negotiations with different suppliers are underway.
